



## Policy Personal Data Protection

Luxury Hospitality Management BV(LH) will comply with the provisions of the EU General Data Protection Regulation 95/46/EC, adopted in April 2016 in relation to how we handle any personal data which we obtain from you.

This statement sets out our Privacy Policy and explains what we do with the Personal Information that we collect from our Users. Please read the following to understand our views and practices regarding Personal Information. Our website uses cookies – small text files that are placed on your machine to help the site provide a better user experience. We use cookies are used to retain user preferences, store information for our live chat application, and provide anonymised tracking data to third party applications such as Google Analytics, Hotjar and Facebook. LH may also request further information from third parties, the so-called Data Processor, or shall disclose your details to other selected third parties and providers of data processing services to LH.

LH will ensure by agreements with our contracted service providers the same level of personal data protection as LH's.

By accepting our services you give LH permission to process your personal data enabling LH to implement the contractual agreement.

In disclosing your personal details to LH, you agree that LH may process and in particular may disclose your personal data:

- as required by law;
- to contracted service providers to;
- in our good faith judgement;
- to comply with legal process;
- to respond to any legal claims or actions;
- or to protect the rights of our customers and the public.

LH will keep your personal data on file as long as LH has a contractual agreement for one or more LH services and -products.

In case of a data leak LH will inform the affected persons and the Dutch Authority immediately on the content of the leak and the LH measures for damage control and future prevention.

When such agreement will cease to exist, LH will delete all personal data from her files.

You have the right to demand deletion of your data from LH files any time without restrictions.
